Interested Parties Summary



Interested Parties Summary (Apr-Nov 2018)

- Since April 2018, two trucking complaints were received
 - Trucking concern regarding trucks on Watts Pond Rd observed to be failing to stop at the stop sign when turning onto Pinehurst Rd. DFA communicated the concern to the OPP, who sent out a message to front line personnel to setup patrols along Watts Pond Rd and ticket violators. OPP had not received any complaints from local neighbours.
 - Concern about truck traffic when Pit opens on a Saturday. Follow-up with the neighbour to discuss that the Pit is able to operate on Saturdays, notices were sent out to local neighbours, and that this is infrequent. Neighbour was satisfied.


Operations Update

- Operations from April 2018 to October 2018 have included:
 - Shipping to customers
 - Processing dry and washed products
 - Rehabilitation tree and pollinator plot planting
- Operations plan for remaining of 2018:
 - Shipping to customers
 - Processing dry and washed products until December
 - Maintenance activities once production season ends



Operations Update

- Stripping northern section
- Progressively mining in southwest corner
- Developing settling pond cells





Operations Update: Community Donations

- In-kind material donations:
 - Gravel loads to neighbours, over 150 tonnes

Planting Programs

- Events held May 1 with Paris FC Girls Soccer Team and a local school
- Planted native tree screen along the perimeter of the site, supporting requirements of the Site Plan: 30 participants planted 400 trees and shrubs
- Planted Oak Savannah prairie grassland and meadow, supporting the Paris Plains natural heritage: 60 participants panted 700 wildflowers and grasses, 80 trees and shrubs
